## Rules and Regulations

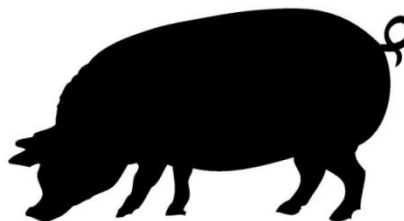
1. Competition is open to all.
2. Entries should be received by July 6th, unless specified otherwise. The address is Cobleskill Agricultural Society, PO Box 249, Cobleskill NY 12043.
3. Late entries, where accepted, will be thru July 13th at an additional charge of \$10.
4. Entry fee is 10% of first premiums or \$7 minimum for all entries, except where noted differently.
5. Judging is scheduled for 5 p.m. Friday, August 11 at the Show Barn.
6. **Exhibits will be received August 6th & 7th between 9 am and 1 pm at the swine barn. All animals must have a health check before leaving transport vehicle.**
7. All animals entered in Section 24 must be accompanied by a certificate of registry or transfer card that will be requested by the judge at the time of judging.
8. Any animal disqualified for participation in the Fair should be removed from the grounds by the end of the same day.
9. All exhibits must be entered in the name of the bonafide owner and such ownership to have existed at least 30 days before showing.
10. Exhibitors on return home from the fair shall keep show animals segregated from herd or flock for a period of at least two weeks.
11. No grain will be furnished to animals by this department.
12. All livestock exhibits will be released between 7 p.m. on Sunday, August 13th and must be off the grounds by noon Monday after the fair's end unless specified differently. Due to the release time and other activities on the grounds, extra measures have been taken to insure that safety and traffic patterns are not impacted in any negative way. Exhibits leaving before the permitted time will forfeit their premium money.
13. No animals shown in breed classes may be shown in market classes.
14. The exhibitor must own all piglets shown as a group.

1. Entries must be received by July 6th. Mailing/payee is Cobleskill Agricultural Society, PO Box 249, Cobleskill, NY 12043.
2. Late entries, where accepted, will be accepted thru July 13th at an additional charge \$10
3. In accordance with the bylaws of the Cobleskill Agricultural Society, Schoharie County resident exhibitors 18 years of age or older have the option to purchase a \$60 6-Day Voting Membership Pass in lieu of the \$10 6-Day Exhibitor Pass.
4. Two 6 Day Guardian Passes per youth exhibitor is available for an adult to accompany the youth. The price for a 6-day Guardian Pass is \$10. Not to be combined with other entry forms.
